Request: Referral from the GT Committee in the interest of the FIA GT3 European Championship which remains subject to the unanimous agreement of the registered competitors in the Championship concerned.

Reason: Increase the number of cars on the grid by extending the possibility for some competitors who have a 2011 model of cars or have developed a car with a kit endurance to be accepted in the FIA GT3 European Championship.

Missions concerned (to be completed by the Committee)*

- 1) drawing up the technical definition of GT3 cars, according to the performance parameters defined by the homologation regulations and to intervene in the process of drawing up the final technical form of these cars,
- 2) amendment and/or adjust the performance parameters of the cars, in order to maintain the balance of performance between the cars,
- 3) help the competitors or tuners to optimise the performance of their cars in an equitable manner,
- 4) examination of any request for a technical change concerning the homologation form of a vehicle,
- 5) prohibition of any developments that would result in a significant increase in the costs of cars,
- 6) examination, if so needed, of any request from a competitor wishing to take part in an FIA event as a "race by race" entrant.
- 7) impose an additional weight penalty of up to 100 kg on cars which miss at least one of the Balance of Performance sessions.

* In compliance with both of the Internal Regulations of the GT Committee and the applicable Sporting Regulations.


